RESOLUTION NO. 2023-23

SUPPORTING THE JEWISH COMMUNITY IN AMBERLEY VILLAGE
AND EXPRESSING SOLIDARITY WITH ISRAEL

WHEREAS, Amberley Village takes pride in its diverse and inclusive community, cherishing the contributions of all its residents, regardless of their backgrounds, beliefs, or heritage; and

WHEREAS, the Jewish community has been an integral part of Amberley Village for generations, enriching our community with their culture, traditions, and values; and

WHEREAS, the State of Israel has been a staunch ally and friend to the United States, promoting shared values such as democracy, human rights, and the rule of law; and

WHEREAS, Amberley Village recognizes that the recent hostilities and conflicts in the Middle East have created an atmosphere of concern and uncertainty, both for our Jewish residents with relatives in Israel and for innocent civilians caught in the midst of these hostilities; and

WHEREAS, Amberley Village seeks to promote peace, understanding, and tolerance among its residents, and to support peaceful resolutions to international conflicts;

NOW, THEREFORE, BE IT RESOLVED BY THE Council of Amberley Village, State of Ohio, six (6) members elected thereto concurring,

SECTION 1: We express our unwavering support for the Jewish community in Amberley Village, recognizing and celebrating the valuable contributions of our Jewish residents to our community.

SECTION 2: We stand in solidarity with the State of Israel and express our support for its right to exist and its commitment to a secure and peaceful future for its citizens.

SECTION 3: We extend our deepest sympathy and concern to our Jewish residents who have family members and friends living in Israel, acknowledging the emotional and psychological toll that the ongoing hostilities may be causing them.

SECTION 4: We hope for a swift and peaceful resolution to the hostilities in the Middle East, one that minimizes harm to innocent lives and seeks a non-combative path toward coexistence and stability in the region.

SECTION 5: We encourage and support diplomatic efforts and dialogue between all parties involved, with the aim of achieving a lasting peace that respects the rights and aspirations of all people in the region.

SECTION 6: We call on the international community and our national representatives to work diligently towards the peaceful resolution of conflicts in the Middle East and to promote understanding and cooperation among nations.

SECTION 7: We reaffirm our commitment to fostering an environment of tolerance, respect, and unity within Amberley Village, where all residents can live in harmony, free from discrimination or prejudice.
